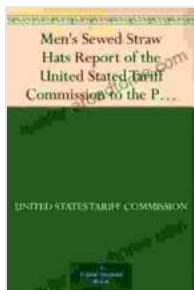


# Men Sewed Straw Hats: Report Of The United Stated Tariff Commission To The

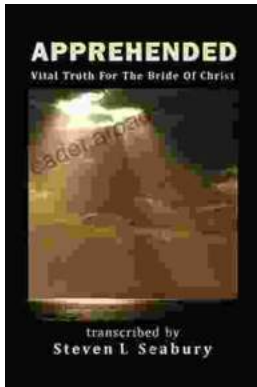
